#### c) Students from remaining countries:

These must be in possession of private medical insurance valid for Spain during the time of their studies and practice in EUHT StPOL. This insurance must show the following:

- Name of the student
- Name of the insurance company
- Policy number
- Validity (in the case of insurance renewal, the renewal receipt must be presented at the secretary's office)

#### NB:

- The contract insurance must be the same as that given in the Spanish consulate for obtaining study visas.
- It is recommendable to confirm how the insurance works in the event of accident or illness with the insurance company.

#### (3) Receipt of payment of the admission fees.

#### Academic amount: €14,865

#### Admission fees

Payment of the €2,700 of the admission fees. This amount must be paid at the office of the school secretary or by bank transfer.

#### a) Uniform and equipment

It's compulsory to have a knife set (3 knifes and a peeler). In case the student does not have one, the school will provide at the following amount to be paid on the first day of classes: €94 (47€ knife set, 47€ knife set case).

#### b) Academic fees

In addition to the included Master diploma awarded by EUHT StPol, it is mandatory that the student choose between two options for University of Girona Diplomas, depending on the student academic profile.

- University Diploma of Specialisation in Culinary Arts awarded by University of Girona.
- Master's Degree in Culinary Arts (Título Propio) awarded by University of Girona. Only for those students who accomplish the academic requirements.

The UdG academic fees for this diploma (900 €) are already included in the tuition, but any scholarship or financial aid will not be applied to or have any effect on this amount.

Furthermore, the University of Girona will require a payment of 185 € per copy in order to issue the diploma, if required.

#### c) Residence and full board

The school has a residence for students with food services. There is also the possibility of contracting food services without residence.

If you are interested, ask at the Admissions Department for the residence form (admissiones@santpol.edu.es).

#### c) Laundry service for uniforms

The hotel-school has an optional laundry service for the school clothing. The cost of this service for the whole course is 190 euros. School residents already have this service included in the price.

#### d) Sending of letter of acceptance for student visa

In order to ensure correct receipt of the letter of acceptance for students to get their visas, the letter will be sent to the following countries by courier (UPS), and must be paid for by the candidate along with the admission fees:

Europe: €65 Russia: €110

Remaining countries: €75

The school will be in charge of sending the student the required certificates to apply for the student visa in the Spanish Embassy/consulate.

It is responsibility of the student to provide the embassy/consulate with the other required documents and to apply for the student visa and, upon arrival in Spain, to provide proof of accommodation in order to confirm residence permit (students will be instructed accordingly on the process upon arrival).



#### NB: Cases of justified relinquishing

When a candidate relinquishes their studies at EUHT StPOL once any amount has been paid for any item (e.g.: admission, enrolment, accommodation and maintenance), the amount paid will only be returned in the following

- When a candidate asks to leave EUHT StPOL, they will only be entitled to be refunded the amounts paid, less a 15% deduction, when they should report their intention in writing at least 90 days before the beginning of the school year.
- When a candidate is not admitted for opportune reasons in the opinion of the Board of Directors, they will be refunded 100% of the amounts paid.
- When a candidate certifies causes considered by the Board of Directors as "force majeure" they will be refunded the amounts paid less a 15% deduction.

In no case will any amount be refunded once the course has started or later than 60 days before it starts.

No amount paid will be refunded in the event of compulsory abandonment due to disciplinary action.

In any case of refund, the candidate will cover all corresponding bank costs.
